PROTOCOL FOR ADVERTISING MEMBERS' EVENTS NOT ORGANISED BY THE CLUB (MENOCs)

In most cases the events appearing in the Newsletter Calendar, and on the website, are official Club events – embracing lectures, day walks, meets, tours, mountain biking, training, and events such as the AGM weekend. However the Club offers members the opportunity to advertise certain events that they organise themselves, but which the Club would not ordinarily choose to run as an official Club event. These events appear in a separate section headed "MENOCs", with appropriate disclaimer as described below. Such events will fall into one of the following categories:

- 1. Events that are not packages but involve commitment to expensive accommodation, and thus do not fall within the criteria for Club meets or tours as set out in the Meet Organisers Guidelines or the Tour Leaders Guidelines.
- 2. Events that are packages as defined by the Package Travel and Linked Travel Arrangements Regulations 2018 (PHR).

Members advertising MENOCs are expected to investigate and comply fully with these regulations. More information can be found on the following links:

Website and Newsletter advertisements for MENOCs

The following wording must be used as a preface:

Members intending to participate in these non-Club events must accept that any arrangement is between them and the organiser of the proposed event, not with AAC(UK). When such an event is arranged through, and monies paid to a tour operator, the tour operator is the organiser, not the member initiating the event. If the event is a package within the definition of the Package Travel and Linked Travel Arrangements Regulations 2018 (PHR), AAC(UK) recommends that such an organiser should be a PHR-compliant tour operator and, if appropriate, ATOL bonded (where a UK tour operator includes air travel in the package).

AAC(UK) cannot vouch for the validity of any information provided for these events. Nevertheless, members wishing to invite other members to join them on specific events by advertising in this section of the Calendar should send their Calendar entry, and a copy of the information they will be supplying to enquirers (this is purely to check that the Club's name is not misused), to the AAC(UK) Office on accordinates and accordinates and accordina
